**WHEREAS**, upon careful examination, validation & verification, THE PHIL. BON BUILDERS & SUPPLY, CO. is the lowest bidder.


**NOW THEREFORE**, on motion made by Ruben V. Diadula Jr. and duly seconded by Roque M. Golindang it was unanimously;




